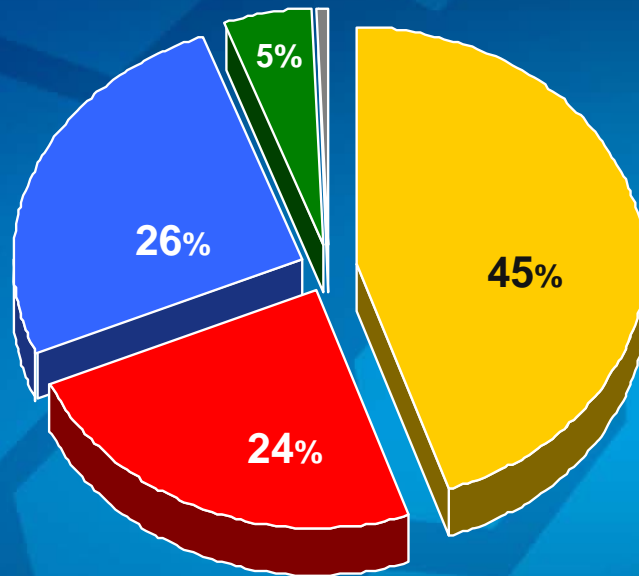

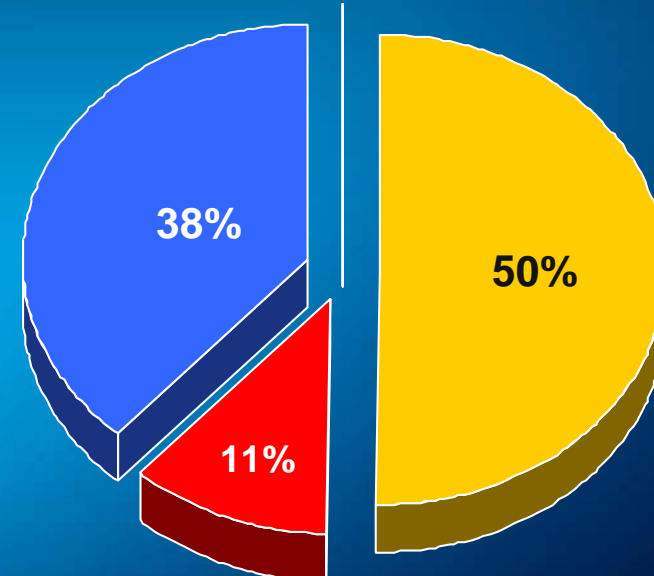

## F2007 EBITDA



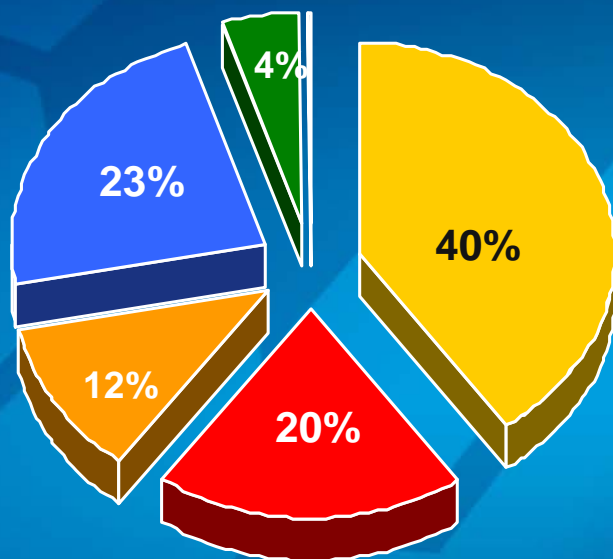

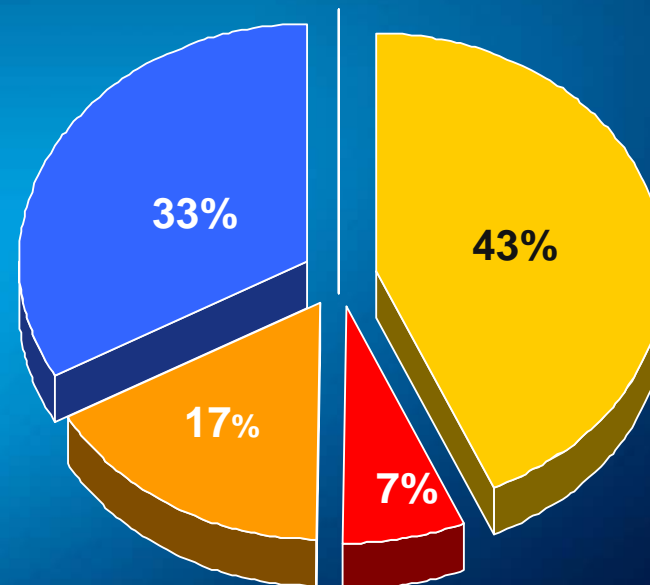
# Segmented Financials (Pro Forma: Including Alliance Atlantis)
